West Coast Rock lobster allocation for the 2017/18 season

Summary

This document reports on details of the west coast rock lobster TAC allocations for the 2017/18 season.

Table 1 reports the initial intended west coast rock lobster allocations by sector and area (second last column) for the 2017/18 season. However, the new small scale sector that was envisaged for this season has not been established yet, hence the 249 MT (Offshore) and 70 MT (Nearshore) originally indicated for this sector have not been allocated. The final column gives the consequent final allocations awarded.

It is proposed that the current assessment assumes that catches made for the 2017/19 season will be as indicated in this final column. I thank Wendy West and Craig Smith (DAFF Management) for providing the information set out in Table 1.
